- (e) I understand that, parents and guardians or a nominated adult that has been appointed by the parent / guardian have sole responsibility for the children and wards in their care and appreciate that the club cannot be expected to exercise supervision or control.
- (f) I understand and acknowledge that the club operates RYA guidance in relation to the protection of Children and Young Persons and RYA guidance in relation to Health, Safety and Security. This information is available to me and a copy is available at the club for my inspection.
